2. Nomination papers must be delivered to the Returning Officer, 1 Belle Vue Square, Broughton Road, Skipton, BD23 1FJ on any working day after the date of this notice between the hours of 9am and 4pm, but no later than 4 pm on Tuesday, 5th April 2022.
3. If any election is contested the poll will take place on Thursday, 5th May 2022.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Thursday 14 April 2022. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at 1 Belle Vue Square, Broughton Road, Skipton, BD23 1FJ by 5 pm on Tuesday, 19th April 2022.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at 1 Belle Vue Square, Broughton Road, Skipton, BD23 1FJ by 5 pm on Tuesday, 26th April 2022.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at 1 Belle Vue Square, Broughton Road, Skipton, BD23 1FJ by 5 pm on Thursday, 5th May 2022. The physical incapacity must have occurred after 5 pm on Tuesday, 26th April 2022. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Tuesday, 26th April 2022.
