Matters Arising.

Tree survey and recommendations: Mr Slingsby recommended that 2 trees be felled, one on Brook Street that overhangs Bernard's garage and the other by the stile near Thorsgill. The copper beech was not a problem as if it did fall it would be into the field. Other ash trees concerning the Council were safe he said. It was decided to ask for 3 quotes to fell the tree on Brook street, from Mr Slingsby of Airedale Trees, Webbers and a 3rd that Cllr Joy will look up.

Town Hill response to letter about state of road: The Clerk had 2 emails concerning the state of the bridleway. There was insufficient response or offer of money so the Clerk will inform the YDNP that no action is being taken. The Clerk will write a follow up letter to the residents involved explaining this.

Land letting up date: There has been 2 sealed bids so far. The Clerk put up 2 notices in Grassington just to further advertise the Land letting.

Wayleaves up date: Most of the money has been paid with just 3 outstanding and they have been sent reminders.
